DRAYAGE/HANDLING CHARGES

The following charges apply for all incoming <u>and</u> outgoing shipments. Drayage charges are the responsibility of each vendor. Charges can must be posted to a Credit Card. (Prices are subject to change)

PAID PARKING

STORAGE

VENDOR ON SITE BELL DESK ASSISTANCE

RETURN SHIPPING
